What is the overall <u>deductible</u> ?	\$7,850 individual / \$15,700 family in-network. \$15,700 individual / \$31,400 family out-of-network.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. In-network preventive services, 3 illness-related office in- network visits, Tier 1 and Tier 2 drugs and some pediatric dental services are covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without <u>cost-sharing</u> and before you meet your <u>deductible</u> . What is the <u>out–of–pocket</u> limit for this <u>plan</u> ?	For in-network \$7,850 individual / \$15,700 family.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limit</u> until the overall family <u>out-of-pocket limit</u> has been met.
What is not included in the <u>out–of–pocket limit</u> ?	All out-of-network cost sharing amounts (deductibles, copays and coinsurance), except out-of- network mental health disorders & substance abuse medical emergency services; except out- of-network medical emergency services and out-of-network air ambulance services; premiums; balance-billed charges; and healthcare this plan doesn't cover.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .

Does this plan provide Minimum Essential Coverage? Yes
