Important Questions	Answers	Why This Matters:
What is the overall <a href="#">deductible</a> ?	\$4,700 / individual or \$9,400 / family in-network. \$9,400 / individual or \$18,800/ family out-of-network.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. In-network <a href="#">preventive services</a> , outpatient hospital services, inpatient hospital services, most <a href="#">physician services</a> , some pediatric dental services and drugs are covered before you meet your <a href="#">deductible</a> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. For example, this <a href="#">plan</a> covers certain <a href="#">preventive services</a> without <a href="#">cost-sharing</a> and before you meet your <a href="#">deductible</a> . Are there other <a href="#">deductibles</a> for specific services?	No.	You don't have to meet <a href="#">deductible</a> for specific services.
What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	For in-network \$9,250 individual / \$18,500 family.	The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services. If you have other family members in this <a href="#">plan</a> , they have to meet their own <a href="#">out-of-pocket limits</a> until the overall family <a href="#">out-of-pocket limits</a> has been met.
What is not included in the <a href="#">out-of-pocket limit</a> ?	All out-of-network <a href="#">cost sharing</a> amounts ( <a href="#">deductibles</a> , <a href="#">copays</a> and <a href="#">coinsurance</a> ), <a href="#">premiums</a> , <a href="#">balance-billing</a> charges, healthcare this plan doesn't cover, and <a href="#">specialty drug</a> coupon programs payments. Exceptions include out-of-network medical <a href="#">emergency services</a> (including mental health and substance abuse) and out-of-network air ambulance services. Will you pay less if you use a <a href="#">network provider</a> ?	Yes. You pay the least if you use a provider in the Hospital Choice Network Lower Member Cost Share tier. You pay more if you use a <a href="#">provider</a> in the Hospital Choice Network Higher Member Cost Share tier. You will pay the most if you use an out-of-network <a href="#">provider</a> , and you might receive a bill from a <a href="#">provider</a> for the difference between the <a href="#">provider's</a> charge and what your <a href="#">plan</a> pays ( <a href="#">balance billing</a> ). Be aware your <a href="#">network provider</a> might use an <a href="#">out-of-network provider</a> for some services (such as lab work). Do you need a <a href="#">referral</a> to see a <a href="#">specialist</a> ?	Yes. Some services require a <a href="#">referral</a> .	This <a href="#">plan</a> will pay some or all of the costs to see a <a href="#">specialist</a> for covered services but only if you have the <a href="#">plan's</a> permission before you see the <a href="#">specialist</a> .
