²PPO Copays: The \$25 primary care copay includes OB/GYN and behavioral health. The \$75 specialty visit copay includes, but is not limited to, chiropractic services (up to 25 visits/year), occupational/physical therapy (up to 60 visits/year).

³PPO Coinsurance: Inpatient visits; surgery; x-rays and lab tests; ambulance; emergency room services; hospital (inpatient/outpatient); maternity care (spouse only); allergy testing/treatment; home health care (up to 120 visits/year); durable medical equipment; mental health/substance abuse treatment.
